1. About ClearView ClearChoice Super Rollover

ClearView ClearChoice Super Rollover is issued by HTFS Nominees Pty Limited (Trustee) as the Trustee for the HUB24 Super Fund (Fund), a complying superannuation fund.

ClearView ClearChoice Super Rollover allows you to rollover monies from another complying superannuation fund into the Fund.

The money invested in ClearView ClearChoice Super Rollover is used to pay the premiums for cover held through ClearView ClearChoice Super. It is not available for any other purpose. ClearView ClearChoice Super Rollover provides only one investment option being a cash and short-term securities investment option.

ClearView ClearChoice Super is a risk only superannuation product that allows you to hold your Life, Accidental Death, Total and Permanent Disability (TPD), Accidental TPD, Income Protection, Income Protection Flex and Accidental Income Protection Cover inside the Fund. ClearView ClearChoice Super is issued by the Trustee of the Fund. You should consider the ClearView ClearChoice Super combined Product Disclosure Statement and Policy Document in deciding whether to acquire or continue to hold that product. To acquire ClearView ClearChoice Super Rollover, you must become a member of the Fund. The Fund is governed by a Trust Deed which is dated 11 May 2012. You can request a copy of the Fund's Trust Deed free of charge by contacting us on **132 979**. You can find the target market determination for ClearView ClearChoice Super Rollover at clearview.com.au/tmd.

The Trustee reserves the right to change any terms and conditions of the ClearView ClearChoice Super Rollover, and will notify you of any change as required by law.

It is important that you are aware of any fees and charges that may apply in relation to a full or partial rollover of benefits from or to any other superannuation account. You should also consider where your future super contributions will be paid and the potential effect of rolling over monies into this product on any existing benefit entitlements (including insurance) in other funds.

The Trustee is required under superannuation law to disclose additional information regarding certain matters such as the details of trustee and officer remuneration, the Fund's Trust Deed and other governance information. 2. How super works

Superannuation is a way for you to save for your retirement, which is in part compulsory.

The payments you can make to ClearView ClearChoice Super Rollover are restricted to rollovers from other complying superannuation funds. You or your employer cannot make contributions into your account. In general, there are different types of contributions that can be made to superannuation funds i.e. employer contributions or personal contributions made by you or your spouse.

Depending on your personal circumstances, you may be eligible for government co-contributions. Most people can choose the superannuation fund into which their superannuation guarantee contributions can be invested.

Because superannuation is designed to provide for you in your retirement, there are restrictions on the contributions that can be made, as well as when you can access your benefit. There are also a variety of government incentives (including tax savings) to encourage you to save using superannuation.

ClearView ClearChoice Super Rollover will not accept contributions.

You should talk with your financial adviser about how superannuation may be appropriate for your individual objectives, financial situation and needs.

Your account balance in ClearView ClearChoice Super Rollover:

- increases by the amount of the funds rolled over from other superannuation funds
- reduces by the amount of taxes, fees and costs deducted
- reduces by amounts rolled over to cover the cost of insurance premiums under ClearView ClearChoice Super
- reduces by the amount of superannuation benefits paid
- reduces or increases according to market movements reflected in the value of your investment in the ClearView ClearChoice Super Cash Fund (being the cash and short-term securities investment option offered in ClearView ClearChoice Super Rollover).

4. Risks of super

Before you consider investing in ClearView ClearChoice Super Rollover, it is important you understand the risks that can affect your investment as these risks are borne by you.

What is risk?

Risk is defined as uncertainty and unpredictability in the level of your returns. Below is a summary of the significant risks of ClearView ClearChoice Super Rollover, but these are not exhaustive and there could be other risks which could adversely impact your investment. You should seek your own professional advice on the appropriateness of this product for your particular circumstances and objectives.

Investment risk

Investment risk is most commonly measured by changes in the level of returns. Generally speaking, there is a positive relationship between returns and risk. While all investments carry risk, assets with the lowest levels of short-term risk may also provide the lowest long-term returns and conversely, assets with higher levels of short-term risk may also provide higher long-term returns.

As a result different investment strategies may carry different levels of risk depending on the assets that make up the strategy. Each person's level of risk will vary depending on a range of factors including age, investment timeframes, other investments you hold and your risk tolerance.

The value of your investment and the level of returns will vary from time to time and future returns may differ from past returns. Often returns are not guaranteed and you may lose some of your investment.

You should also consider the risk that the performance of your investment may not meet your investment objectives.

In other words, there is a chance that you might not be able to meet your investment goals over your investment timeframe with your choice of investments and therefore your superannuation savings (including contributions and returns) may not be enough to provide adequately for your retirement.

ClearView ClearChoice Super Rollover offers only one investment option which is the ClearView ClearChoice Super Cash Fund. The purpose of this product is to pay the premiums for cover held through ClearView ClearChoice Super.

General risks

There is a risk that:

- superannuation laws (including tax laws) may change in the future and may adversely affect your investment
- the Trust Deed of the Fund may change without your consent
- there may be a delay in processing transactions, and
- if you do not have sufficient monies in your account to pay your insurance premiums, your insurance cover may be cancelled.

5. How we invest your money

Your rollover monies in ClearView ClearChoice Super Rollover are invested in a life investment policy which, after the deduction of insurance premiums and any taxes that are immediately payable, issues units in the ClearView ClearChoice Super Cash Fund. The life investment policy is issued to us by ClearView Life.

The ClearView ClearChoice Super Cash Fund invests 100% in cash and short-term securities. This is a unitised investment option and ClearView Life guarantees the capital (money) invested less net withdrawals which include tax, fees and premiums paid for ClearChoice Super cover. No part of your investment return is guaranteed.

This guarantee is provided from the assets of the ClearView Life Statutory Fund No. 2.

Warning: You should consider the likely investment return, risk and your investment timeframe when deciding whether to invest in ClearView ClearChoice Super Rollover.

We may change the investment option in the future (which may include adding other investment options, or closing or altering the investment option). If this occurs we will notify you in accordance with the law.

6. Fees and other costs

DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term returns. For example, total annual fees and costs of 2% of your account balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs. You or your employer, as applicable, may be able to negotiate to pay lower fees. Ask the fund or your financial adviser.*

Increases or alterations to fees and costs

We may increase existing fees and charges or impose additional fees at our discretion (without your consent). In addition, ClearView Life may vary the fees and also introduce new fees or charges for the services that it provides to us by varying the fees under the policy it issues by notification to us (and without your consent).

We will consider the actions available to us in respect of any proposed fee variation.

If ClearView Life increases or varies the fees or costs under the policy held by us and we determine to pass the fee increase or variation on to the Fund members, or if we otherwise decide to introduce any additional fees or increase existing fees and charges, we will give you at least 30 days advance written notice.

We may at our discretion reduce or waive any of the fees and costs disclosed in this PDS.

7. How super is taxed

The laws relating to superannuation, including tax laws, can be complex. This section has been prepared as a general guide only and is not personal advice.

This summary is based on our understanding of the Australian laws effective as at the date of this PDS. Any of these may change without notice. Any changes in tax laws or their interpretations or associated administration practices could affect the tax treatment of members.

You should consult your financial adviser and/or tax professional on superannuation rules and for tax advice specific to your circumstances.

Tax on investment earnings

Investment income incurs tax at a maximum rate of 15% in superannuation, allowing for the benefit (if any) of tax deductible expenses. The net effect of investment income, tax and fees, is reflected in the product unit prices.

Tax File Number (TFN)

Important: You will need to provide us with your TFN as part of your application for this product.

We can collect, use and disclose your TFN under the *Superannuation Industry (Supervision) Act 1993 (SIS Act)*. Declining to provide your TFN is not an offence. However we will not accept your application without a valid TFN.

Superannuation Rollover Tax Benefit

When you pay your ClearView ClearChoice Super insurance premium via this product, you may receive the benefit of a 15% tax deduction on the premium. The benefit will only apply to the part of the premium covered by the rollover. This tax benefit has no cash value and will not be carried forward. It applies under an arrangement with us and ClearView Life and may be withdrawn or changed at any time. We will notify you if this occurs.

Goods and Services Tax (GST)

You don't pay GST on either your account or your benefit payments.

Tax on withdrawals

The amount of tax payable on a lump sum withdrawal if you are under the age of 60 depends on the individual components making up the benefit. There is generally no tax payable on withdrawals when you are age 60 or over or on rollovers to other super funds.

8. How to open an account

Applications

Applications to ClearView ClearChoice Super Rollover can only be made with your financial adviser on an application form. To obtain the application form, contact your financial adviser or call us on **132 979**. Please read the declarations and acknowledgements before signing.

About the cooling-off period

As a new member of the Fund, you are entitled to a 30-day cooling-off period. The 30-day cooling-off period commences at the earlier of:

- when you receive confirmation of your investment, or
- the end of the fifth day after you became a member.

Provided you have not exercised any rights as a member during the cooling-off period you can cancel your membership by notifying us in writing or by electronic means before the end of the cooling-off period.

If you cancel your membership, you will receive back any rollovers you have made less any adjustments we are required or permitted to deduct. Preserved and restricted non-preserved components of your member account balance must be transferred to another complying superannuation fund.

We will acknowledge your complaint within one business day (being Monday to Friday except for public holidays in Sydney NSW) of receiving it, or as soon as practical.

We aim to address your complaint within 45 calendar days and will provide a final response to your complaint in writing or via electronic communication:

- for complaints about superannuation death benefit distributions, within 90 calendar days after the expiry of the 28-calendar day period for objecting to a proposed death benefit distribution, and
- for all other complaints, within 45 calendar days of receiving your complaint.

If you make a complaint and the Trustee resolves it within 5 business days from receipt to your satisfaction, we are not required to send you a formal complaint response, unless you request one; or your complaint relates to hardship or for any decision of a trustee (or failure by the trustee to make a decision) relating to a complaint.

In exceptional cases where there is no reasonable opportunity for us to respond within the applicable timeframe above because resolution of the complaint is particularly complex or because of circumstances beyond our control which cause complaint management delays, we will need more time to respond to your complaint.

In these cases, before the applicable timeframe above expires, we will provide you with a notice:

- telling you that we need more time setting out our written reasons for the delay
- clearly communicating our revised expected timeframe, and
- setting out information about your right to take your complaint to the Australian Financial Complaints Authority (**AFCA**) if you are dissatisfied and the contact details for AFCA.

AFCA provides fair and independent financial services complaint resolution that is free to consumers. You are able to lodge a complaint directly with AFCA, however we encourage you to contact us first so we can resolve the matter with you and if you have not done so, they will likely refer you back to us in any event.
